“Chinese Government Graduate Student Overseas Study Program
(国家建設高水平大学公派研究生項目)”

(Graduate Schools of Law, Economics, International Relations, Policy Science, Letters, Core Ethics and Frontier Sciences and Technology Management)

Based on the “Chinese Government Graduate Student Overseas Study Program (国家建設高水平大学公派研究生項目)” conducted by the China Scholarship Council, Ritsumeikan University will be accepting applications for September 2024 enrollment to Doctoral Programs, as well as enrollment to the third year of the Integrated Doctoral Program, from Chinese international students, as detailed below.

II. Eligibility Requirements

Applicants must meet all the eligibility criteria for the Chinese Government Graduate Student Overseas Study Program, be enrolled in, or have completed the academic program of, one of the graduate schools listed in the chart below or at a graduate school at a university with a memorandum of understanding with Ritsumeikan University (with the exception of Beihang University, Beijing Institute of Technology and Harbin Institute of Technology), and must meet at least of one of the following conditions.

- (1) Persons who have been awarded a degree equivalent to a master's degree or professional degree, as defined by Japanese law, abroad or who are expected to be awarded such a degree before being enrolled in the graduate school
- (2) Persons who have been engaged in research activities at a university or research institute for at least two years after graduating from a university or its equivalent and who have been recognized by Ritsumeikan University's graduate schools as having an academic ability equal to or greater than holders of a master's degree (the 1989 Notification of the Ministry of Education, Science, Sports and Culture No.118) (*)
- (3) Persons who have been recognized by Ritsumeikan University's graduate schools as having an academic ability equal to or higher than holders of a master's degree or professional degree, as defined by Japanese law, as a result of individual preliminary screening and who have reached 24 years of age (*)

* Applicants who intend to apply under category (3) or (4), above, must contact the International Center at BKC no later than the day before the application period begins in order to undergo an individual review.

IV. Application Procedures

1. Application Fee

- (4) Certificate of Graduation or Program Completion (or Expected Graduation or Expected Program Completion), from the university (Graduate School) attended by the applicant by which they fulfill the eligibility requirements
- (5) Master's thesis and/or Master's thesis abstract
 - *All text within the PDF version to be submitted via email must be clearly legible and readable by text-recognition software. Further, if applying to the Graduate School of Policy Science the full Master's thesis must be submitted. If applying to the Graduate School of Economics, the full Master's thesis **and** Master's thesis abstract must be submitted.
- (6) Copy of passport page(s) showing name and birthdate or certified copy of family register or citizen register from home country. (Applicants in possession of a valid passport should submit the passport copy)
- (7) Copy of documentation showing objective proof of level of linguistic ability

Proof of English Ability (required only for students applying to English language-based courses)

- Submit a grade certificate from an English Language Ability Test (Score reports must be from one of the following: TOEIC® Listening & Reading Test, TOEFL iBT® Test, TOEFL iBT® Home Edition, IELTS, IELTS Indicator or Duolingo English Test. Copies are acceptable).
- *Test must have been taken in the two-year period preceding the application deadline to be acceptable.
- Applicants who cannot submit a score certificate from one of the tests above must submit an original, formal certificate of English language ability level issued by their current university, or the equivalent (formal letter, etc.).
- *Certificate must have been issued within the two-year period preceding the application deadline to be acceptable.
- *In principle, applicants who intend to submit this form of certificate must consult with the Ritsumeikan University International Center at BKC in advance.

Proof of Japanese Ability (required only for students applying to Japanese language-based courses)

- Submit score reports from the "Japanese as a Foreign Language" score from the Examination for Japanese University Admission for International Students (EJU), or the Japanese Language Proficiency Test (JLPT). (Copies are acceptable)
- *Test must have been taken in the two-year period preceding the application deadline to be acceptable.
- Applicants who cannot submit a score certificate from one of the tests above must submit an original, formal certificate of Japanese language ability level issued by their current university, or the equivalent (formal letter, etc.).
- *Certificate must have been issued within the two-year period preceding the application deadline to be acceptable.
- *In principle, applicants who intend to submit this form of certificate must consult with the Ritsumeikan University International Center at BKC in advance.

- (8) Original letter of recommendation from your current university (Optional, freeform).
- (9) For graduates of universities in mainland China: Print out and submit your 教育部学历证书电子注册备案表 and 中国高等教育学位在线验证报告.
For current students of universities in mainland China: Print out and submit your 教育部学籍在线验证报告.
*In both cases, only English language versions of the forms are accepted.

3. Important Points

- (1) All application documents must be in Japanese or English and, to the maximum extent possible, should be typed in word processing-type software and printed on A4-sized paper. Documents in any other language must be accompanied by a certified Japanese or English translation.
- (2) On all documents, your date of birth must be written exactly as it appears in your passport.
- (3) On the Ritsumeikan University Graduate Application Sheet, your name must be written in the Roman alphabet exactly as it appears in your passport, and following the rules below.
 - * Write your name in the order of Family name (all uppercase), First name (the first letter in uppercase and the rest in lowercase), and Middle name (the first letter in uppercase and the rest in lowercase).
 - * For names without a clear distinction between surname and first name, write the first part of the name in all uppercase and for the rest, write the first letter in uppercase and the rest in lowercase.Example: Family Name: RITSUMEI First Name: Taro Middle Name: Saionji
On other forms, fill out your name as per the instructions contained within the form.
- (4) All documents must be sent by international express post or registered mail to the address in 4. below.
- (5) Once your application documents have been accepted, they will not be returned for any reason.
- (6) If it is determined that your application documents contain any plagiarism, or any deliberate falsifications or forgeries, your examination and/ or admissions may be denied.
- (7) About Security Export Control

Ritsumeikan University has established the “Ritsumeikan University Security Export Control Regulations (立命館大学安全保障輸出管理規程)” in accordance with the “Foreign Exchange and Foreign Trade Act”, and conducts strict screening of international students at the time of admissions on the basis of these regulations. Please be aware that international students who fall under any of the conditions set out in the Act may be unable to receive their desired education or conduct their desired research at the university. A stringent screening in accordance with the “Foreign Exchange and Foreign Trade Act” will be conducted after your application documents are received.

*Applications post-marked by the final date of the application period will be accepted.

Application Mailing Address below by 11:59 pm (Japan Standard Time) on February 1st, 2024, the final day of the application period.
